Subject : Guidelines for conduct of written test / interview for Direct Recruitment.

In order to streamline the procedure to be followed by concerned departments in making direct recruitments including contract appointment, the Executive Committee is pleased to order that all Departments should conduct written examination and personal interview even if recruitment rules are silent on the matter.

However, in cases where the number of applicants for a posts / post is less than the prescribed number to be called for interview as indicated at 2, below, recruitment should be done by means of personal interview only, and it will carry a maximum mark of 100.

The subject for written examination where the service rules / recruitment rules do not specially prescribed syllabus for recruitment, shall be as under:
